## Summary of the Main Activities of the Charity During the Financial Period

The Honorary Secretary reported to the Board of the Edward Clark Bequest on the terms of the Trust Deed and other documents held in the National Records of Scotland. She has also participated in a number of events to promote the use of the Edward Clark Collection to students and researchers.

At the request of Historic Environment Scotland, the Honorary Secretary attended two meetings at the Blairgowrie Print Works to participate in discussions about its future. She has investigated the history of the machines in the works, pending plans for the refurbishment of the building and its contents.

The Honorary Secretary attended a number of meetings of the Scottish Transport and Industrial Collections Knowledge Network committee. She also worked with Curators at National Museums Scotland, to organise an event around printing and museum collections, to take place in October 2023 as part of a UK-wide programme run by the Centre for Printing History and Culture at Birmingham City University.

The items belonging to SPrAT that are currently held in the Edward Clark Collection are being organised and listed. A preliminary catalogue is available at: www.librarything.com/profile/PrintScot The collection as a whole is under review, with the intention of making archival material more accessible and reducing duplication. This feeds into plans for future space requirements.

The Trust began the process of change its trading name to *Scotland's Printing Heritage*, which better reflects the nature of its activities.

#### Events

The Honorary Secretary was invited to give talks on the heritage of the Scottish printing industry to a range of groups, including the Glasgow & West of Scotland Family History Society and the Bathgate Probus Club. She also conducted a number of guided walks in Edinburgh for interest groups.

#### Website

The Trust's main website (<u>www.scottishprintarchive.org</u>) was updated occasionally throughout the year with matters of interest. The number of visitors to the website increased by a third during the period, and the number of followers on Twitter/X continued to rise slowly, and stood at 452 at the end of the period.

Changes to the design and organisation of the site are under consideration.
